



## **APPLICATION FOR RECIPROCAL GUEST PASS AND ROVER TICKETS - 2019** **AUSTRALIAN CLUBS**

**There is no Reciprocal Arrangement in place for the I.C.C. Cricket World Cup.**

### **Eligibility**

A Member of a Reciprocal Club may obtain a Reciprocal Guest pass, limited to a single four-week period, provided that they meet the following criteria:

- They are a full voting Member;
- They are over 16;
- They do not work or maintain a residential address in the United Kingdom.

### **Entitlements for Major Matches**

**Pass:** Eligible Members of Reciprocal Clubs are entitled to a Reciprocal Guest Pass, limited to a single four-week period, costing £75, which provides the holder with entry to the Ground, Pavilion and unreserved seating in the Members' Friends' Enclosures for the following match days at Lord's:

- Royal London One-Day Cup Final – Saturday 25th May 2019;
- England v. Ireland Test Match Days 2-4 – Thursday 25th, Friday 26th and Saturday 27th July 2019;
- Middlesex Twenty20 Cup matches;
- England v. Australia Test Match Days 4-5 – Saturday 17th and Sunday 18th August 2019.

**Tickets:** Subject to availability, tickets for major matches can be pre-purchased by completing the form included. Rover tickets admit relatives or friends to unreserved seats in the Members' Friends' Enclosures, but not the Pavilion.

**Please note: all applications for a Reciprocal Guest Pass which include any of the Major Match days listed above must be received by the 9th January 2019. Failure to do so will result in access to the ground being denied.**

**If the four-week period excludes the England v. Australia Test Match the Pass will be free of charge.**

### **Entitlements for Matches at Lord's not listed above (Non-major matches)**

**Pass:** Eligible Members of Reciprocal Clubs are entitled to a Reciprocal Guest Pass, limited to a single four-week period, free of charge, providing access to the Ground, Pavilion and Members' Friends' Enclosures. Please note that if prior application for a Reciprocal Guest Pass has not been received, admission to the Pavilion cannot be guaranteed.

**Tickets:** Subject to availability, ground admission tickets for guests for non-major matches can be purchased from the Ticket Sales Window at the Ground.

Reciprocal Guest Pass holders will be able to introduce a guest into the Pavilion for non-major matches, subject to meeting the dress regulations.

**A confirmation of the request will be sent via email. This email will also include collection details for the Reciprocal Guest Pass and tickets. No tickets or passes will be sent out by post.**

**Please Note:**

Reciprocal Guests are **not** permitted to purchase or wear M.C.C. colours.



## CONDITIONS RELATING TO THE ALLOCATION AND SALE OF TICKETS TO AUSTRALIAN CLUBS 2019



Full Members of Reciprocal Clubs are entitled to apply for a Reciprocal Guest Pass at £75 which, when valid, admits to the Ground, Pavilion and Members' Friends' Enclosures. A Reciprocal Member may only have one Pass issued to them.

The Reciprocal Pass is valid for a FOUR WEEK period starting from the first match attended. The pass provides admission on the Second, Third and Fourth Days of the England v. Ireland Test Match and the Fourth and Fifth Days of the England v. Australia Test Match.

Privileges may be extended for other matches at Lord's during the period that your pass is valid. Full details are obtainable from the M.C.C. Membership Office.

The application form is for purchasing Public Stand tickets for the First Day of the England v. Ireland Test Match and the first three days of the England v. Australia Test Match, and Rover Tickets for the Second, Third and Fourth Day of the England v. Ireland Test Match and the Fourth and Fifth Day of the England v. Australia Test Match. The maximum number of tickets which a Reciprocal Guest can purchase is specified in the relevant column below on the application form. The availability of tickets is not guaranteed.

If a Member's application for a Reciprocal Guest Pass and/or tickets is successful the applicant will receive a confirmation by email. This email will also include collection details for the Reciprocal Guest Pass and Tickets if relevant. The Pass or Tickets will NOT be sent by post.

### **Applications**

Reciprocal Guests may apply for Unreserved Rover and Public Stand tickets by the completion and submission of the England v. Ireland and England v. Australia Test Matches application form with the appropriate arrangements made for payment. The closing date for Reciprocal Guests' applications is Wednesday 9th January 2019.

### **Fifth Day Tickets**

In order to satisfy the anticipated demand for tickets for the Australia Test, it has been decided to make tickets for the Fifth Day (Sunday 18th August) available for purchase in advance. Such tickets will be non-refundable and non-returnable. Instead, and whether or not the match reaches the Fifth Day, the surplus from their sale will be donated to the MCC Foundation.

### **Tickets for Disabled Spectators**

Please email [reciprocalclubs@mcc.org.uk](mailto:reciprocalclubs@mcc.org.uk) or call 020 7432 1000 before completing this form if the tickets being requested are for the use of a Reciprocal Member's guest who has a disability but is not a wheelchair-user, or is acting as a companion for a Reciprocal Member who is disabled but is not a wheelchair-user. A member of staff will then provide advice on how to proceed.

### **Refunds**

A refund scheme applies to the **first four days** of the Australia Test Match and **all four days** of the Ireland Test Match. On those days, if play is restricted or does not take place on the day for which the ticket is valid, an automatic refund will be made to the original ticket purchaser, subject to there being:

- (i) 15 overs or less because of weather conditions or completion of the match – a full refund; or
- (ii) 15.1 overs to 29.5 overs because of weather conditions or completion of the match – a 50% refund.

### **Returns**

If a Reciprocal Guest has to return, to M.C.C., tickets for **any day** of the Ireland Test Match or any of the **first four days** of the Australia Test Match, the Club will attempt to re-sell such tickets, but only after all other tickets for the relevant day have been allocated. If tickets are returned to the Club within six weeks of the match day for which the ticket is valid, a charge of 20% of the face value of each ticket will be deducted by M.C.C. from the proceeds of such sales. Tickets may be returned only by the original applicant.

### **Duplicates**

A duplicate ticket, issued as a replacement for any ticket which has been stolen, lost or temporarily mislaid, or is defective or damaged, will be issued by M.C.C. only on production of a written statement by the Reciprocal Guest who originally purchased the ticket. If stolen, it is imperative that the theft is reported to the Police in order that a crime number can be allocated. This number is to be quoted in the Reciprocal Guest's written statement requesting duplicate tickets. An administrative charge of 10% of the face value will be made for each duplicate ticket.

### **General Conditions for Test Matches**

Any ticket which is allocated to any Reciprocal Guest shall not be used for commercial hospitality by any person or company trading for that purpose; and without prejudice to the generality of the foregoing, the holder of such a ticket shall not, as part of a hospitality package, or for any other reason, purvey, advertise or otherwise offer for sale, or use as a competition prize (including for use in a raffle or auction), the ticket or tickets allocated to that person without written permission of the Chief Executive & Secretary of M.C.C.

All tickets are allocated subject to M.C.C. Ground Regulations, which are hereby incorporated into these Conditions. Additional copies are displayed at all entrances to the Ground, around Lord's and are available from M.C.C. on request of the Chief Executive & Secretary.

### **Members' Friends' Enclosures**

Tickets for the Members' Friends' Enclosures are solely for use by Reciprocal Guests and their guests. Reciprocal Guests remain responsible at all times for tickets which are allocated to them and for the behaviour of the guests to whom tickets are passed. Reciprocal Guests are also responsible for ensuring that their guests fully understand that tickets are strictly non-transferable and that they are aware of the Dress Regulations which govern entry to the Members' Friends' Enclosures.

*Postal applications* may be submitted earlier, but will receive no priority over application forms received on Wednesday 9th January 2019.
