



## PRIORITY WAITLIST APPLICATION FOR ADMISSION AS A SACA MEMBER

To be eligible for priority SACA Membership, you must first complete an online waitlist application form at [www.membership.saca.com.au/join](http://www.membership.saca.com.au/join) and make the \$40 waitlist payment. Once this has occurred, your Priority Waitlist Application will be considered by the SACA Board upon completion of this form.

If your Priority Waitlist Application is granted by the SACA Board, you will move to the top of the SACA Member waitlist. You will receive your Membership offer the next time offers are made by the SACA Board. Offers may not occur every year and are at the discretion of the SACA Board. Membership entrance fees are also applicable.

This form is to be completed by the Club Secretary with whom the applicant is affiliated. The applicant must satisfy the minimum requirement of ten years' senior service with Premier / Grade Cricket as a player, administrator, scorer and/or umpire or have represented South Australia in a first class international or interstate cricket match. If two clubs or more are involved, then the applicant must attach information validating years of service.

Clause 1.15 and 1.16 of the Membership of SACA By-Laws state:

**1.15 South Australian Cricket Representatives and Service to Cricket**

- (a) Without limiting clause 3.6 of the Constitution, the Board may, in its absolute discretion, give priority for admission to any application for Membership made by:
- (i) a person who has represented South Australian in any first class international or interstate cricket match; or
  - (ii) such person as may be nominated by the Board in recognition of outstanding service to cricket.
- (b) Unless otherwise determined by the Board, a person referred to in by-law 1.15(a) shall make application for Membership in accordance with by-law 1.9 and may accept a Membership Offer in accordance with by-law 1.11.

**1.16 Priority**

For the avoidance of doubt, by laws 1.10(b), 1.13(b), 1.14(a) and 1.15(a) do not limit the absolute discretion of the Board to give priority for admission to a person on any ground in accordance with clause 3.6 of the Constitution.
